

# HOLD HARMLESS AND MEDICAL RELEASE FORM

### ADMISSION REQUIREMENTS AND PARK RULES

1. *Hold Harmless* forms must be signed in the presence of the Skate Park attendant.
2. Minors need to have both of their parents sign the *Hold Harmless* form, preferably in the presence of the Skate Park attendant.
3. All participants must wear a helmet. Children ages 10 and under must wear a helmet, wrist protectors, kneepads, and elbow pads at all times while they are skating or are in the skating area. Protective gear strongly encouraged for all skaters.
4. *Skating is restricted to the Skate Park only!* Skating outside of the park will result in suspension of Skate Park privileges.
5. Skaters not obeying the direction and/or instruction of the Skate Park attendant will lose Skate Park privileges.
6. Food and water not permitted in the Skate Park.
7. Shirts and shoes required at all times.
